Written Comments to Senate Higher Education Committee March 15, 2017

RE: Senate Bill 1066

Good morning, Chair Seliger and Members of the Committee.

I am writing on behalf of the Teaching Hospitals of Texas in support of SB 1066, which recognizes the importance of Graduate Medical Education (GME) residency programs as an integral part of medical education, and requires a plan to support residency positions for new medical school graduates.

The Teaching Hospitals of Texas, as you can tell from our name, has a special focus on supporting healthcare education in Texas. Our members provide about two-thirds of the hospital based residency programs in Texas.

There is a reason there are insufficient residency positions in Texas: these positions and programs are underfunded. THOT members and other teaching hospitals, however, have stepped into the breach to support Texas' physician supply and our medical school investments by supporting residency programs.

Because Medicare underfunds GME, in particular in Texas, and since Medicaid no longer supports the direct costs of GME, residency programs in Texas face significant shortfalls. An analysis of 2015 Medicare cost reports showed that on average 85% of direct GME costs for Teaching Hospitals of Texas members were unfunded. That's on average over \$78,000 in unfunded direct GME residency costs per resident per year.

Globally, over \$400 million in Texas GME costs are unfunded. For THOT hospitals, unfunded GME costs are estimated to be over \$125 million just for the unfunded Medicaid share of Graduate Medical Education costs. These unfunded costs put additional pressure on our healthcare system and our local property taxes.

Recognizing that medical schools and residencies are two integral parts of producing a Texas physician is an important policy approach. We appreciate your work in support of Texas healthcare, workforce and residencies.

¹ Estimated GME costs are \$528.5 million using Medicare cost methodologies (which under-trend actual costs). About 21% of this amount is funded by Medicare. (THOT members' Medicare funding is about 15% of GME costs.) Medicaid's share for all teaching hospitals would be \$173 million for all Texas teaching hospitals in 2018; and about \$126 million in 2018 just for THOT members.
